We would like to inform you that the Cyprus Medicines Verification System (CyMVS) has been connected to the European Hub on the **25**<sup>th</sup> **of June** and is now in live production environment.

Reaching this goal would not be possible, without the help of all our colleagues from other NMVO's with Solidsoft – Reply, who have offered their assistance generously, helping us to reach this important milestone. Our very special thanks to the team of the Slovenian NMVO (ZAPAZ), the EMVO team, the supporting team at Solidsoft – Reply and all our Board Members, particularly KEFEA<sup>1</sup> and PASYPAGEF<sup>2</sup>, who were actively engaged in this project and have supported us during this difficult last year.

Within the coming weeks we will advance to the next phase of the project, involving participants who have already joint or, are in the process of on-boarding the EU Hub, as well as, a limited number of end users, who will all together, participate in the limited production phase. Our intention is to initiate an information campaign targeting all user groups and registering all individual users on the CyMVS, so that they can flawlessly engage to the production phase during system ramp up.

At this stage, it is very important for OBP's connected to the hub to start/continue with the upload of product and pack data to the EU hub intended for dispensing in our market. Multi market packs intended for Greece and Cyprus should only be loaded on our system, until the Greek system will be up and running.

Taking this opportunity, we would also like to thank the MAH's who have already registered with KOEΦ and have settled their fees for the Setup and Deployment phase.
